Approval of Resolution No. 2022-41 —Authorizing an increase of the not-to-exceed amount related to the Final Approval of Lease Revenue Bonds (Greenville University — Student Housing and Athletic Facilities Project), to be issued in one or more tax-exempt and/or taxable series, to a principal amount of not-to-exceed \$35,500,000, for the benefit of MACQ — Illinois I, LLC.

Kelly McGuire, Esq., Kutak Rock LLP, gave an overview of the original financing request, noting that there is a shortage of authorization for approximately \$485,000 of bonds needed to achieve the financing. Harper Watters of Wells Fargo Securities and underwriter of the bonds then provided additional details of the increase in the amount

requested for the project and offered to entertain questions from the Board. Board member <u>Gary Naquin</u> asked if the project was planning on closing soon, and Ms. McGuire said it is scheduled to close this Thursday.

Board member <u>Lea Márquez Peterson</u> then motioned to approve Resolution No. 2022-41. Board member **Ken Burns** seconded the motion.
